 Candidates are required to filled the Registration Form and sent the filled-in Registration Form as an attachment in the E-Mail to be sent to RPBDHRNEIST@GMAIL.COM
- 3. The Subject of the E-mail should be mentioned as "Application for Apprenticeship".
- 4. Candidates for Graduate Apprentice and Technician Apprentice (Diploma) are required to register themselves in National Apprenticeship Training Scheme (NATS) portal

(www.mhrdnats.in)

- 5. Candidates for Trade Apprentice (ITI) are required to register themselves in National Apprenticeship Promotion Scheme (NAPS) portal (www.apprenticeshipindia.gov.in)
- **6.** Validity of NAPS /NTPS Registration should be at least up to 31/12/2025.
- 7. Candidates with essentials qualification in regular mode courses are only eligible
- 8. Candidates are requested to bring with them all **ORIGINAL TESTIMONIALS** including Mark sheets and Certificates and also a Photograph on the date of the interview, failing which their candidature may not be considered. Candidates are also to fulfil medical standards before the training begins.
- 9. The applicants will be subjected to the short listing by the Selection Team based on the Academic qualification (Marks) and only shortlisted candidates will be called for Offline interview to be held at CSIR-NEIST, Jorhat.
- 10. The list of shortlisted candidates along with the Date and Time of Interview will be uploaded in the CSIR-NEIST website.
- **11.** Candidates need not pay any application fee.
- **12.** During selection, due weight-age will be given to the academic performance. The candidates should have knowledge of computer for day-to-day work.
- **13. Duration:** The duration of the Apprentice will be one year.
- 14. The selected candidates must execute a contract for a period of one year of training as per provision of the Apprenticeship Act 1961 and rules framed there under.
- 15. Age: As on closing date
 - I. Minimum 21 and Maximum 26 for Graduate Apprentice
 - II. Minimum 18 and Maximum 24 for Technician Apprentice
- III. Minimum 18 and Maximum 23 for ITI Apprentice

Age relaxation is applicable as per the Govt rule for reserved categories.

- **16.** The offer of Apprenticeship does not confer any right of employment in CSIR-NEIST.
- **17.** CSIR-NEIST reserves the right of withdraw/cancel the advertisement/selection process if circumstance arises.

- **18.** Reservation of Post for SC/ST/OBC (Non Creamy Layer) /EWS/PWD are applicable as per Govt rules.
- **19.** No TA/DA will be paid to the candidate for the Interview.
- 20. Result awaited candidate need not apply.
- 21. The Candidate who have undergone Apprenticeship earlier or pursuing Apprenticeship Training in the industry as per the Apprenticeship Act, 1961/1973/1992 as amended from time to time or job experience for a period of 1 year or more are NOT eligible.
